

GENERAL RULES

(1) Permits for use of facilities should be picked up at least 3 work days in advance of use date, with the exception of Swim Pool rental permits, which must be picked up 5 work days in advance of use date.

(2) Charges must be paid at the time permit is issued.

(3) Applicant must be 18 years or older.

(4) Usage is limited to permit time.

(5) Use of profane language or intoxicating liquors is prohibited.

(6) Charging admission, selling tickets or soliciting money in any manner, without Recreation Division permission, is prohibited.

(7) Groups using the facility will be responsible for any damage which may result.

(8) Groups must notify the Recreation Division office - 644-6530 - in case of cancellation.

(9) Requests for refunds must be accompanied by original copy of permit, original receipt, and a letter of justification.
